Opposition to Proposed Changes to DDCS Waiver Eligibility

[The Community Advocacy Coalition for Developmental Disabilities \(CAC\)](#) is a statewide alliance representing self-advocates, families, and service providers. We are committed to ensuring people with intellectual and developmental disabilities (IDD) can live safely, participate meaningfully, and thrive in their communities. We are **opposed to the governor's proposal to change functional eligibility** criteria for support from Developmental Disabilities Community Services (DDCS)

Individuals and families will be pushed into crisis as they lose essential, preventative support. We recognize the difficult fiscal decisions you need to make, but pulling services is both harmful and fiscally unsound. The need for support does not go away, and loss of care cannot be absorbed by families.

Loss of Medicaid Match and Increased State Costs

DDCS services are primarily funded through Medicaid and come with significant federal matching dollars. Reducing eligibility **reduces federal revenue**. At a time when federal Medicaid funding is uncertain, this proposal would unnecessarily forfeit dollars while increasing pressure on the state general fund.

Cost-Shifting to Crisis Systems

The proposal assumes savings by serving fewer people, but in practice, it just **shifts costs**. When individuals lose access to community-based supports, the need does not disappear. It escalates. Families turn to hospital emergency rooms, crisis stabilization services, law enforcement, homelessness systems, and inpatient care. These settings are far more expensive than community-based services and are widely acknowledged to be less effective and less humane. Preventative support is not a luxury; it is a cost-containment strategy.

Families Losing Support Before Crisis Occurs

The individuals most affected by this proposal are those with lower, but still critical, support needs. These are often people living with family members who rely on limited DDCS services to maintain stability, employment, housing, and safety. Raising eligibility thresholds means families must wait until situations

deteriorate significantly before help is available. This approach undermines family caregivers, increases burnout, and places individuals at greater risk of institutionalization or system involvement that could have been avoided.

Impact on Children and Long-Term Outcomes

The proposed changes would also increase eligibility thresholds for children, requiring substantially higher levels of need before services are available. Early and consistent supports are foundational to long-term independence, health, and community participation. Delaying access until needs intensify contradicts decades of evidence showing that early intervention reduces long-term costs and improves outcomes for both children and families.

Our Request

We respectfully urge the Legislature to **reject any changes to DDCS waiver eligibility**. Preserving access to Medicaid-funded community services protects federal revenue, prevents costly crises, supports families, and upholds Washington's longstanding commitment to serving people with disabilities in the community.

The Community Advocacy Coalition remains committed to working collaboratively with legislators to identify solutions that address fiscal challenges **without shifting costs onto families, emergency systems, or people with disabilities themselves**.
